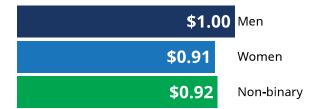


Mean hourly pay gap¹

In this organization women's average hourly wages are 10% less than men's and non-binary people's average hourly wages are 9% less than men's. For every dollar men earn in average hourly wages, women earn 90 cents and non-binary people earn 91 cents in average hourly wages. *

Median hourly pay gap²



In this organization women's median hourly wages are 9% less than men's and non-binary people's median hourly wages are 8% less than men's. For every dollar men earn in median hourly wages, women earn 91 cents and non-binary people earn 92 cents in median hourly wages. *

- 1. "Mean hourly pay gap" refers to the differences in pay between gender groups calculated by average pay. Hourly pay does not include bonuses and overtime.
- 2. "Median hourly pay gap" refers to the differences in pay between gender groups calculated by the mid range of pay for each group. Hourly pay does not include bonuses and overtime.



Mean overtime pay ³



In this organization women's average overtime pay is 22% less than men's and non-binary people's average overtime pay is 69% less than men's. For every dollar men earn in average overtime pay, women earn 78 cents and non-binary people earn 31 cents in average overtime pay. *

Median overtime pay 4



In this organization women's median overtime pay is 30% less than men's and non-binary people's median overtime pay is 78% less than men's. For every dollar men earn in median overtime pay, women earn 70 cents and non-binary people earn 22 cents in median overtime pay. *

In this organization the average number of overtime hours worked by women was 21 less than by men and the average number of overtime hours worked by non-binary people was 121 less than by men. *

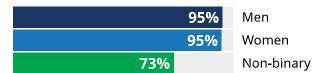

Mean bonus pay ⁷



In this organization women's average bonus pay is 5% less than men's and non-binary people's average bonus pay is 65% less than men's. For every dollar men earn in average bonus pay, women earn 95 cents and non-binary people earn 35 cents in average bonus pay. *

Median bonus pay ⁸



In this organization women's median bonus pay is 7% less than men's and non-binary people's median bonus pay is 82% less than men's. For every dollar men earn in median bonus pay, women earn 93 cents and non-binary people earn 18 cents in median bonus pay. *

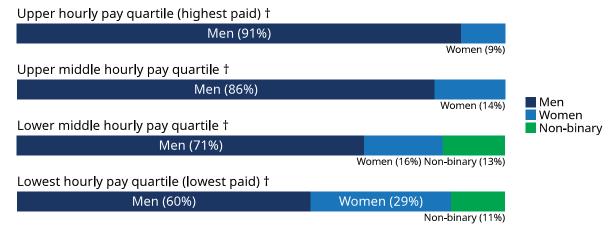

Percentage of each gender in each pay quartile ⁹



In this organization, women occupy 9% of the highest paid jobs and 29% of the lowest paid jobs. Non-binary people occupy 11% of the lowest paid jobs.
