## **ENVIRONMENTAL TECHNICAL LEAD/COORDINATOR**

This position is for work at our mine located 80 km south of Dease Lake, BC in Tahltan traditional territory. The successful applicant will be required to work and stay in camp during their shift rotation. We offer a number of designated flight marshalling points within BC. Qualified applicants from local communities are encouraged to apply.

## RESPONSIBILITIES

Reporting to the Environmental Superintendent, the duties of the Technical Lead/Environmental Coordinator include:

- Provide support to the environmental management, protection, and reclamation programs at Red Chris Mine.
- Lead technical team to implement routine water quality monitoring program at the mine site.
- Provide mentorship to technicians to develop their scientific data collection, management and analysis skills.
- Implement studies of lentic and lotic ecosystems through data collection, data analysis and reporting.
- Contribute to technical documents, regulatory reports, management plans and departmental standard operating procedures.
- Advise and support RCDC management and operational planning in environmentally-sensitive areas.
- Manage technical projects and support consultants contributing to scientific studies onsite.
- Maintain compliance with Environmental Assessment Certificate, permit commitments and MDMER regulation by implementing industry best practices and provincial and federally-mandated environmental regulatory standards.

## **QUALIFICATIONS AND EXPERIENCE**

The ideal candidate will have:

- BSc in related field of study minimally required (biology, biogeochemistry, forestry, environmental science, ecology, etc.); MSc Preferred;
